7. Proclamation of October as Domestic Violence Awareness Month in Marshall County

WHEREAS, Home should be a place of warmth, unconditional love, tranquility, and security, and for most of us, home and family can indeed be counted among our greatest blessings. Tragically, for many Americans, these

are blessings that are tarnished by violence and fear;

WHEREAS, Every 9 seconds a woman in the United States is assaulted by an intimate partner;

WHEREAS, 1 in every 3 teenagers, 1 in every 4 women, and 1 in every 6 men will experience domestic violence during their lifetime;

WHEREAS, An average of 3 women are murdered by intimate partners in the United States every day and a person experiencing strangulation in a relationship is 7 times more likely to be murdered by their partner and, according to the American Psychological Association, the presence of a gun in a domestic violence situation increases the risk of homicide by 500 percent;

WHEREAS, According to the Bureau of Justice Statistics Crime Data Brief, Intimate Partner Violence, women accounted for 85 percent and men accounted for 15 percent of survivors of intimate partner violence;

WHEREAS, Women and men are not the only targets; children, the elderly, family pets and responding law enforcement officers are counted among the survivors;

WHEREAS, According to a study by Break the Silence, witnessing violence is the strongest risk factor in transmitting violent behavior from one generation to the next;

WHEREAS, According to the National Resource Center on Domestic Violence, approximately 23 percent of LGBTQ men and 50 percent of LGBTQ women experience abuse at the hands of their intimate partners;

WHEREAS, Domestic violence costs an estimated \$8.3 billion annually in medical care, mental health services, and lost productivity on the job. Women, men and children living with domestic violence suffer higher rates of physical injuries, chronic health problems, depression, PTSD, attempted suicide, substance abuse, behavior problems for children, and homelessness;

WHEREAS, the problem of domestic violence is not confined to any group or groups of people, but crosses all economic, racial, gender, educational, religious, and societal barriers, and is sustained by societal indifference;

WHEREAS, survivors of violence should have access to medical and legal services, counseling, sheltering, transitional housing and other supportive services so they can escape the cycle of abuse;

WHEREAS, we as a county encourage survivors and their families to see assistance from appropriate survivor services organizations, including ACCESS, LUNA, and other local programs and state coalitions;

WHEREAS, the Iowa Domestic Violence Helpline is 1-800-770-1650 and the ACCESS Crisis Hotline is 1-855-983-4641;

WHEREAS, it is important to recognize the importance of the compassion and dedication of individuals who serve survivors of domestic violence and their families, including local programs, state coalitions, national organizations, criminal and juvenile justice agencies, health care providers, law enforcement, allied professionals, and survivor services

organizations;

WHEREAS our community must make ending domestic violence a priority;

NOW, THEREFORE, BE IT RESOLVED That the Marshall County Board of Supervisors, proclaim the month of October as Domestic Violence Awareness Month in Marshall County and urge our citizens to observe this month by becoming aware of the tragedy of domestic violence and supporting those who are working toward its end.
