**A RESOLUTION TO APPROVE A WAIVER OF MARSHALL COUNTY'S RIGHT
TO APPEAL ISSUANCE OF FINAL CONSTRUCTION PERMIT FOR THE
CONSTRUCTION OF CONFINED ANIMAL FEEDING OPERATION BY THE
IOWA DEPARTMENT OF NATURAL RESOURCES.**

BE IT RESOLVED by the Marshall County Board of Supervisors as follows:

Section 1. The Marshall County Board of Supervisors has received notice from the Iowa Department of Natural Resources (DNR) that Kevin Blood Dairy, Facility ID 60101 has been issued a draft permit for the construction of a confined animal feeding operation building(s) in the SW ¼ of the NW ¼ of Section 22, T83N, R20W, in incorporated Marshall County.

Section 2. The Marshall County Board of Supervisors reviewed the construction permit application and the manure management plan and determined that both appeared to be in compliance with the requirements of the Master Matrix, Iowa Code Section 459 and the Iowa DNR rules and recommended approval of said application on 09-10-2012.

Section 3. The Marshall County Board of Supervisors hereby waives its right to appeal the issuance of the final permit within the fourteen (14) day limit from the time of receipt of notice of the issuance of the draft permit.

Section 4 The Marshall County Board of Supervisors encourages the Iowa DNR to issue the Final Permit immediately upon notification of this waiver.

Section 5. The Marshall County Board of Supervisors authorized the Board Chairman to notify the Iowa DNR of this waiver.

Section 6. This resolution shall take effect immediately.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF MARSHALL COUNTY: Waives Marshall County's right to appeal issuance of final construction permit for the construction of confined animal feeding operation by the Iowa Department of Natural resources for Kevin Blood Dairy, Facility ID 60101.
