RESOLUTION ADOPTING A TITLE VI PLAN AND STANDARD DOT TITLE VI ASSURANCES

WHEREAS, Marshall County periodically receives federal aid funds for projects; and,

WHEREAS, the Federal Highway Administration (FHWA) and IDOT have recently determined that entities must be more proactive in Title VI compliance in order to be eligible for said funds; and,

WHEREAS, Marshall County will make every effort so that no person shall, on the grounds of race, color, national origin, or sex as provided by Title VI of the Civil Rights Act of 1964, and the Civil Rights Restoration Act of 1987 (P.L. 100.259), be excluded from or participation in, be denied benefits of, or be otherwise subjected to discrimination under any program or activity.

WHEREAS, Marshall County further assures every effort will be made to ensure nondiscrimination in all of its committees, programs, and activities, regardless of the funding source.

WHEREAS, it is in the best interest of the County to stay current with all requirements for federal funds.

NOW, THEREFORE, BE IT RESOLVED BY THE Marshall County Board of Supervisors, that Marshall County adopts a formal Title VI Nondiscrimination Policy Agreement and the Standard DOT Title VI Assurances.
