10. Change in Law Regarding Appointment of Mental Health Advocates—On April 24, 2015 Governor Branstad signed into law several amendments(Sections 229.1 a, b & d, 229.3 and 229.5) to Iowa Code Section 229.19 regarding appointment of mental health advocates.

Pursuant to Section 229.5: Sets out a transition process for advocates to be appointed by County Boards of Supervisors by stating, “an advocate appointed by the Chief Judge of a Judicial District or by the County Board of Supervisors prior to July 1, 2015, shall be considered appointed by the County Board of Supervisors on July 1, 2015, as required by subsection 1. Such an advocate shall be compensated at a minimum at the advocate’s wage and benefit level in place immediately prior to July 1, 2015.”
