MARSHALL COUNTY REQUIRED CASH CONTRIBUTION
Resolution #2015-0043**

Whereas the Region 6 Housing Trust Fund in 2015 can apply for \$268,579 of Iowa Finance Authority State Housing Trust Funds if the R6HTF secures at least \$67,145 of local contributions, and

Whereas the funds are allocated by the R6HTF to each county on a per capita basis, and

Whereas R6HTF is requesting a match from Marshall County of \$36,530 for a share of the state grant in the amount of \$115,086, and

Whereas the fund can be used for qualified rental and owner occupied housing improvement activities for income qualified people across Marshall County, and

Whereas all the applicants must have annual incomes under 80% of the county median as determined by HUD, with at least 30% being reserved for households under 30% of the county median.
