**A RESOLUTION TO APPROVE THE REGION 6 HOUSING TRUST FUND
MARSHALL COUNTY REQUIRED CASH CONTRIBUTION
RESOLUTION NO. 2016-0033**

Whereas the Region 6 Housing Trust Fund in 2015 can apply for \$259,092 of Iowa Finance Authority State Housing Trust Funds if the R6HTF secures at least \$64,773 of local contributions, and

Whereas the funds are allocated by the R6HTF to each county on a per capita basis, and

Whereas R6HTF is requesting a match from Marshall County of \$36,530 for a share of the state grant in the amount of \$111,021, and

Whereas the fund can be used for qualified rental and owner occupied housing improvement activities for income qualified people across Marshall County, and

Whereas all the applicants must have annual incomes under 80% of the county median as determined by HUD, with at least 30% being reserved for households under 30% of the county median.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF MARSHALL COUNTY:

Section 1: Marshall County will provide \$36,530 of cash assistance in FY 2017/2018.

9. Resolution #2016-0034

**Compensation for Election Board Members – Precinct Chairperson
Resolution #2016-0034**

WHEREAS pursuant to §49.20, Code of Iowa, the members of election boards shall be deemed temporary state employees who are compensated by the county in which they serve, and shall receive compensation at a rate established by the board of supervisors, which shall be not less than the minimum wage established in section 91D.1, subsection 1, paragraph "b", while engaged in the discharge of their duties and shall be reimbursed for actual and necessary travel expense at a rate determined by the board of supervisors, except that persons who have advised the commissioner prior to their appointment to the election board that they are willing to serve without pay at elections conducted for any school district or a city of three thousand five hundred or less population, shall receive no compensation for service at those elections. Compensation shall be paid to members of election boards only after the vote has been canvassed and it has been determined in the course of the canvass that the election record certificate has been properly executed by the election board and:

WHEREAS the current compensation rate is \$9 per hour;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors that the compensation rate be established at \$11.00 per hour for the Precinct Chairperson designated at each election and precinct, effective upon passage of this Resolution #2016-0034.
