Merged Area VI (Education) Community College District

For the Special Proposition: Public Measure A

“Shall the Iowa Valley Community College District (Merged Area VI) in the Counties of Butler, Franklin, Grundy, Hamilton, Hardin, Jasper, Marshall, Poweshiek, Story and Tama, State of Iowa, be authorized to renovate, improve, repair, construct, erect, furnish, and equip existing buildings, at multiple campus and enrollment locations, with an emphasis on safety, security, and sustainability; to construct, erect, remodel, repair, renovate, improve, furnish, and equip student housing buildings and additions to existing student housing building; and issue its school bonds in an amount not exceeding \$32,000,000 for such purposes?”

Public Measure A needed 60% to pass and FAILED with 58.44%.
