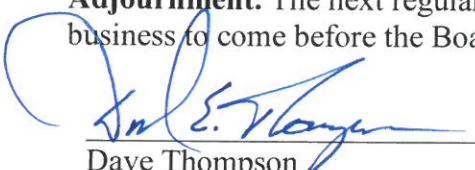
Purpose: Deliberation, Sheriff Candidates.

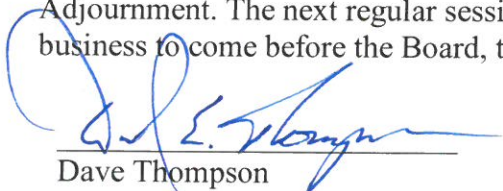
Purpose: Deliberation, Attorney Candidates.
