

**Marshall County Board of Supervisors

MINUTES

The Marshall County Board of Supervisors met in regular session according to the posted notices in the Marshall County Election Center, 107 S 1st Avenue, Marshalltown, Iowa, and online via ZOOM. Chair Thompson called the meeting to order on August 30, 2022, at 9:05 a.m. and led the Pledge of Allegiance. Present: Chair David E Thompson, Vice Chair Steve Salasek, Member Bill Patten. Patten moved to approve the agenda, second by Salasek. Motion carried 3-0.

Proclamation of September as Recovery Month in Marshall County

WHEREAS, according to the Treatment Episode Data System, Iowa has the 7th highest number of methamphetamine use disorder treatment admissions in the United States; and

WHEREAS, according to the Centers for Disease Control, 22 percent of Iowa adults report binge or heavy drinking; and

WHEREAS, according to the Centers for Disease Control one in five Americans will experience a mental illness in a given year; and

WHEREAS, the according to the Iowa Governor's Office of Drug Control Policy, the first month of 2022 resulted in the seizure of more illicit opioids and fake pills than all of 2021 in Iowa; and

WHEREAS, behavioral health is an essential part of a person's wellness; and

WHEREAS, prevention and treatment of mental health, substance use, and co-occurring disorders is effective; and

WHEREAS, recovery is essential to the well-being of a person and the community; and

NOW, THEREFORE, BE IT RESOLVED THAT, we, the Marshall County Board of Supervisors, do hereby proclaim September 2022 as Recovery Month in Marshall County to raise awareness in our community, to assist and celebrate more people in achieving sustained long-term recovery, and to encourage all of Marshall County to observe and support Recovery Month 2022.

Darcy Maiden-Parks, Substance Abuse Counselor at SATUCI, read the Proclamation. Salasek moved, second by Patten, to proclaim September 2022 as Recovery Month. Motion carried 3-0.

Patten moved to adopt the **Consent Agenda**, second by Salasek. Motion carried 3-0. Items:

1. Approve Regular Session Minutes, August 16, 2022.
2. Approve claims as audited and authorize the County Auditor and Recorder to issue payment of the same. The listing of claims paid at this meeting and all claims paid in the current month will be published as part of the first meeting of the following month.
3. File Clerk of District Court Report: July 2022. General Supplemental Fund Surcharge: \$344.35
4. File Manure Management Plans:
 - a. Bill Havelka Section 28, ID 61559, 1413 Wallace Ave, Marshalltown, no changes;
 - b. Jeff Breja ID 65417, 1951 Hart Ave, State Center, no changes.

Personnel Changes:

Motion by Salasek, second by Patten, to approve New Hire, Sheriff Department, Deputy Sheriff, Andrew Cole, Permanent Full Time, \$28.37/hr., with a start date on or after 9/12/2022. Motion carried 3-0.

Motion by Patten, second by Salasek to set fee at \$450.00 for Marshalltown Arts and Civic Center and approve use of Band Shell for Grand Opening event, September 18, 2022. Motion carried 3-0. The Arts Center submitted a completed application, insurance certificate and payment. Nancy Burke, Director of Operations for the Center, discussed the donation request, as the Center benefits the whole of Marshall County, and explained the Arts Center does not have a revenue stream to cover this cost. Patten explained he is aware of individuals interested in covering the cost of the fee. Auditor and Recorder Benson explained the State Auditor is cracking down on local government donations to non-profits, as state law has specific requirements for local government support of non-profit, and a donation of this type is not in compliance with state law. County Engineer Geilenfeldt added that the fee of \$450 does not completely cover the cost of moving and setup of the band shell, and the fee has not been updated in over 12 years.

Salasek moved to adopt **Resolution 2022-0030 Abatement of Real Estate, 719 4th Ave, Marshalltown**, second by Patten. Motion carried 3-0.

Whereas, pursuant to Chapter 445.16, Code of Iowa, the County Treasurer has the authority to determine when it is impractical to pursue collection of property taxes through the tax sale or lawsuit remedies; and

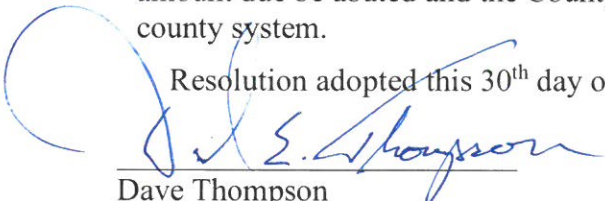
Whereas, upon making this determination the County Treasurer shall provide a recommendation of abatement to the Board of Supervisors, and the Board shall abate the following taxes, which totals include penalty and interest:

Real Estate: 719 N 4th Ave, Marshalltown, Iowa, Parcel 8418-26-277-001 of \$1,192.00.

Now, Therefore, Be it Resolved, by the Marshall County Board of Supervisors that the amount due be abated and the County Treasurer is directed to strike the amounts due from the county system.

Tabled item removed and approved: Application for SARA system relating to Emergency Communication System. Patten moved to remove the item for discussion, second by Salasek. Motion carried 3-0. Patten moved to approve the SARA application, second by Salasek. There is no cost to the county for this service. Motion carried 3-0.

Public Forum:

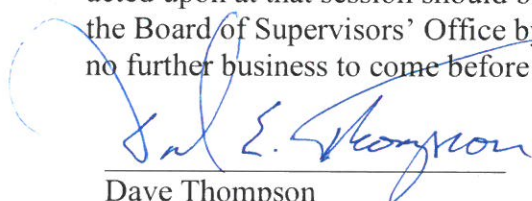
Braudis and Elder updated the board on the ARPA funding request for the previously approved \$500K ARPA funding purpose to equipping a backup site and recorder system. \$100K is needed for the recorder system. E911 recommends a \$400K mobile command center that could be used county-wide and serve multiple jurisdictions. There was no action taken by the board.

Benson noted County offices will be closed for Labor Day. Also, September 14th First Interstate Bank will close at noon for Community Service, however, Marshall County will be open, patrons will need to use the north door. The BCLUW school Special Election will be on September 13th and only have one polling site at Liscomb. Individuals may absentee vote at the Auditor/Recorders office at the bank location, 11 N 1st Avenue.

Elder shared upcoming training opportunities.

Braudis explained there are some issues with the non-emergency phone call line, with individuals being diverted to voice mail. Should individuals have this problem, Braudis asked them to call back and let the dispatchers know they left a message. Doing so will help Braudis determine the extent of the of the problem and assist with resolution.

Adjournment. The next regular session is September 13, 2022, at 9:05 a.m. All business to be acted upon at that session should be submitted to the County Auditor and Recorder's Office or the Board of Supervisors' Office by Wednesday, September 7, 2022, at 12:00 p.m. There being no further business to come before the Board, the meeting is adjourned at 9:52 a.m.
