MINUTES

The Marshall County Board of Supervisors met in regular session according to the posted notices in the Courthouse, First Floor Meeting Room 1 East Main Street, Marshalltown, Iowa, and online via ZOOM. Chair Heil called the meeting to order on July 3, 2024, at 9:00 a.m. Present: Chair Jarret Heil, Vice Chair Steve Salasek, Member Carol Hibbs. Hibbs moved to approve the agenda second by Salasek. Motion carried 3-0.

Salasek moved to approve the Consent Agenda, second by Hibbs. Motion carried 3-0. Items:

1. Approve claims as audited and authorize the County Auditor and Recorder to issue payment of the same. The listing of claims paid at this meeting and all claims paid in the current month will be published as part of the first meeting of the following month.
2. Personnel Changes:
 - a. Approve new hire, Public Health, Taylor Appelgate, part time PRN, \$33.48 per hour, to start on or after July 8, 2024.

 - b. Upchurch Feeders, Inc #66010, 70508 Hwy 30, Colo, signed with changes.
4. Approve the annual publication of salaries, in accordance with Section 349.18, Code of Iowa, this is the salary listing for FY 2023-2024.

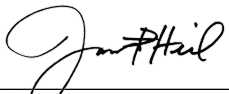
Approval For the Marshall County Veteran Relocation Assistance Program.

Motion by Hibbs, second by Salasek to approve the Home Base Iowa program for Marshall County Veteran Relocation Assistance funding of up to \$2,000 per eligible veteran, up to \$16,000 total program expense through June 30, 2025, with the program applications received by the Marshall County Veterans Affairs Director, to be paid from the County's budgeted Economic Development fund following approval by the Board of Supervisors. Marshall County Veterans Affairs Director Kevin Huseboe provided clarification on this item. There is one application ready to go for this program and there is another Veteran going through the housing process right now that will be putting an application in as well. Huseboe also mentioned that on the First Tuesday of every month beginning in August, Coffee and Camaraderie will be hosted at the Harry C Harter VFW Post 839, 107 E Meadow Lane in Marshalltown from 7:30 AM - 10:30 AM. This will be a monthly get together for veterans to support each other and visit with each other. They are also planning to bring in guest speakers to assist veterans with any concerns or issues they may be having. Motion carried 3-0.

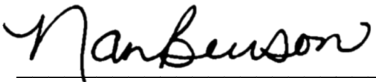
Public Forum. There were no public comments.
