The Marshall County Board of Supervisors met for the regular meeting according to the posted notices in the Courthouse, First Floor Meeting Room 1 East Main Street, Marshalltown, Iowa, and online via ZOOM. Chair Hibbs called the meeting to order on April 9, 2025, at 9:00 a.m. Present: Chair Carol Hibbs, Vice Chair Jarret Heil, Member Kevin Goodman. Goodman moved to approve the agenda second by Heil. Motion carried 3-0.

Project FM-C064(147)--55-64 –HMA Resurfacing with Milling – On E41, from Story County line, east 3.5 miles to State Center and south 3/8 mile to 2ndSt NW, and authorize the Chair to sign the contract and bond when available. Motion, second. Motion carried 3-0.

Approve quarterly transfer of \$750,000.00 from Rural Services Fund to Secondary Road Fund. Motion, second. Motion carried 3-0.

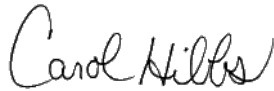
