MINUTES

The Marshall County Board of Supervisors met for the special meeting according to the posted notices in the Courthouse, First Floor Meeting Room, 1 East Main Street, Marshalltown, Iowa, and online via ZOOM. Chair Heil called the meeting to order on April 29, 2026, at 8:45 a.m. Present: Chair Jarret Heil, Vice Chair Carol Hibbs, Member Christian Goodman. Hibbs moved to approve the agenda second by Goodman. Motion carried 3-0.

Approve Marshall County FY2026 Secondary Roads Amended DOT Budget and Authorize the Chair to Sign.

Motion by Hibbs, second by Goodman to approve the Marshall County FY2026 Secondary Roads amended DOT Budget and authorize the Chair to sign. Paul Geilenfeldt, Marshall County Engineer, stated that this DOT budget amendment matches the numbers on the recently amended Marshall County budget for FY2026. Motion carried 3-0.

Approve Marshall County FY2027 Secondary Roads DOT Budget and Authorize the Chair to Sign.

Motion by Goodman, second by Hibbs to approve the Marshall County FY2027 Secondary Roads DOT budget and authorize the Chair to sign. Geilenfeldt provided clarification and stated that this FY2027 DOT budget also matches the FY2027 Marshall County budget. Motion carried 3-0.

Approve Marshall County FY2027 Secondary Roads DOT Five Year Program and Authorize the Chair to Sign.

Motion by Hibbs, second by Goodman to approve the Marshall County FY2027 Secondary Roads DOT Five Year Program and authorize the Chair to sign. Geilenfeldt gave a brief overview of some of the projects in the Five Year Program, including projects on Highway E63, Shady Oaks Rd, and Oaks Ave. Motion carried 3-0.

Approve Supplemental Agreement for Final Design Service with Calhoun-Burns and Associates for Bridge O-06 and Authorize the Chair to Sign.

Motion by Goodman, second by Hibbs to approve the Supplemental Agreement for Final Design Service with Calhoun-Burns and Associates for Bridge O-06 and authorize the Chair to sign. Geilenfeldt stated that this agreement is for the bridge south of Haverhill on Oaks Ave and that they are currently in the process of acquiring additional right of way for the project. Motion carried 3-0.

Public Forum. Marshall County Auditor/Recorder Nan Benson stated that the annual Phyllis Perry Hulton scholarship meeting is taking place on May 6, 2026 at the Marshall County Election Center and that last year, over \$200,000 was given to Marshall County graduates. Geilenfeldt brought attention to an ongoing drainage issue on Oak Park Rd, where surface water is running down into a ditch and is causing issues for a property owner. Heil provided information on a Times Republican article that will be running documenting the history of road names in Marshall County.
